Looking back there were so many things I should have seen. At first, he started monopolizing my time from school and my friends, and then it progressed to time away from my family. Before I knew it, I was pregnant with my oldest child. It didn't get any better from there—it got worse. That is when the physical abuse started and being pregnant didn't stop it. This cycle of abuse went on for about two years.

When I realized he was going to kill me and my unborn son, I was able to find the strength to leave. As soon as I was able to, I went to the legal aid office in Midland, Texas, for the help I needed. Thankfully, they helped get me through the divorce process.


This is where the pro bono clinics come into play. Several months ago, I started helping at the pro bono clinics for Legal Aid of Northwest Texas. At first I started going to the clinics on the second and fourth Tuesday of the month; after that I started going to as many they had in a month as time allowed. While at one of these clinics, I was speaking to the coordinator about why I chose to help. To me, this is my way of giving back to those that helped me. I've been where a lot of these people are that come to us for help.

At one of the recent clinics, I met a young single mother whose story was similar to mine. Not only do these people need legal advice and assistance, they need a sympathetic ear. I told this single mother not to give up and no matter what there was always hope for her to make her life and her children's lives better. I didn't tell her my story but told her she was headed on the right path; getting an education in order to be able to have a career to provide for her children and for her to be able to stand on her own two feet.

Even just being there to listen to their story and to be able to cry without being embarrassed, makes a huge difference in these people's lives. I continue to do this while working full time, my responsibilities with my local chapter, and raising my family; it's just a matter of prioritizing. I promise you, you will not be disappointed in getting involved.

#### NALS Code of Ethics & Professional Responsibility

Members of NALS are bound by the objectives of this association and the standards of conduct required of the legal profession.

Every member shall:

- \* Encourage respect for the law and the administration of justice;
- \* Observe rules governing privileged communications and confidential information;
- \* Promote and exemplify high standards of loyalty, cooperation, and courtesy;
- \* Perform all duties of the profession with integrity and competence; and
- \* Pursue a high order of professional attainment.

Integrity and high standards of conduct are fundamental to the success of our professional association. This Code is promulgated by NALS and accepted by its members to accomplish these ends.

**Canon 1.** Members of this association shall maintain a high degree of competency and integrity through continuing education to better assist the legal profession in fulfilling its duty to provide quality legal services to the public.

**Canon 2.** Members of this association shall maintain a high standard of ethical conduct and shall contribute to the integrity of the association and the legal profession.

Canon 3. Members of this association shall avoid a conflict of interest pertaining to a client matter.

Canon 4. Members of this association shall preserve and protect the confidences and privileged communications of a client.

**Canon 5.** Members of this association shall exercise care in using independent professional judgment and in determining the extent to which a client may be assisted without the presence of a lawyer and shall not act in matters involving professional legal judgment.

Canon 6. Members of this association shall not solicit legal business on behalf of a lawyer.

**Canon 7.** Members of this association, unless permitted by law, shall not perform paralegal functions except under the direct supervision of a lawyer and shall not advertise or contract with members of the general public for the performance of paralegal functions.

**Canon 8.** Members of this association, unless permitted by law, shall not perform any of the duties restricted to lawyers or do things which lawyers themselves may not do and shall assist in preventing the unauthorized practice of law.

Canon 9. Members of this association not licensed to practice law shall not engage in the practice of law as defined by statutes or court decisions.

**Canon 10.** Members of this association shall do all other things incidental, necessary, or expedient to enhance professional responsibility and participation in the administration of justice and public service in cooperation with the legal profession.

# Domain Name Disputes

Domain names on the Internet are registered regist on a first-come, first-serve basis. Domain potent name registration services, or registrars, do trader not inquire into the motivation of the person preve who is purchasing a domain name. Trafficking in domain names is big business in the United States and around the world. If a domain name pirate can divert just a portion of the website traffic that would normally go to the brand owner, the broker can often confuse consumers and pocket some of the revenue stream that would otherwise go to the brand owner. Sometimes the goal of the pirate is to sell the domain name at a premium to its rightful owner. I see some clients shell out the money for these domain names to avoid a fight. There are other options:

1. Purchase defensive domain names.

I am seeing more and more businesses register additional domain names as a defensive measure. These companies are

registering domain names that could potentially be confused with their business or trademark. Pre-emptive registrations prevent these similar domain names from being registered by someone else. It costs about \$15 to register a domain name for a year. I call these defensive domain name registrations "\$15 insurance policies."

2. The litigation option.

Litigation is another option for the trademark owner. The Anti-Cybersquatting Consumer Protection Act, or ACPA, is a federal law adopted to address the problems caused by domain name registrants with unsavory motives. Under ACPA, a person or entity can bring suit in federal court against anyone who in bad faith registers or uses a domain name that is identical or confusingly similar to a distinctive trademark.

ACPA gives the court the power to cancel the infringing domain name registration. The court could also transfer the domain name to the injured party. The injured party may be able to recover statutory damages ranging from \$1,000 to \$100,000 per domain name. In some cases, the injured party can recover attorneys' fees. 3. Domain name arbitration.

The most popular option I see in Texas is domain name arbitration. In 1999, the policy-making body that oversees domain name registries adopted a Uniform Domain Name Dispute Resolution Policy (UDRP). Under UDRP, when a registrant purchases a domain name, the registrant warrants that the domain name does not infringe upon or violate the rights of any third party and that the domain name was not registered for an unlawful purpose. All registrants must also agree to submit to an administrative proceeding to determine the status of the domain name if a complaint is filed.

In these domain name arbitration proceedings, the complaining party must prove all of the following:

- the domain name is identical or confusingly similar to a trademark or service mark in which the complainant has rights;
- the holder of the domain name has no right or legitimate interest in the domain name; and
- the holder of the domain name is using the name in bad faith.

There are no hard and fast rules for determining bad faith. Bad faith is likely to be


found if the domain name was registered for the sole purpose of selling the domain name to the trademark owner or to prevent the trademark owner from using its trademark in its own domain name. Proof of bad faith can also be demonstrated where the domain name is registered primarily to disrupt a competitor's business or to unfairly divert Internet users from the trademark owner's website.

The holder of the domain name can retain the name by showing rights or a legitimate interest in the name. If the holder was commonly known by the domain name before the dispute, or the holder uses the name for a noncommercial purpose, the holder may prevail.

UDRP provides an exclusive remedy: transfer the domain name to the complainant or to cancel the domain name registration. The domain name arbitrator cannot award costs or attorneys' fees to the prevailing party. UDRP is designed to be a costeffective and efficient alternative to litigation. Disputes are typically resolved within 45 days after filing the complaint. If the trademark owner seeks a limited remedy in a short amount of time, UDRP can be an effective tool to combat troublesome domain name registrations.

# **CHEF'S CORNER**

Spanísh Coffee Cake

2 1/2 c. sífted flour 3/4 c. white sugar 1 c. brown sugar 1 tsp. cínnamon 1/2 tsp. salt 3/4 c. salad oil 1 tsp. soda 1 tsp. baking powder 1 c. buttermilk \* 1 egg

Mix first 6 ingredients together thoroughly and remove 1 cup of this crumbly mixture to use as the topping and mix it with 1/3 cup nuts (walnuts or pecans, or you can leave them out). Mix soda and baking powder with the crumbly mixture. Mix beaten egg and buttermilk. Add half of this liquid to crumbly mixture and beat at medium speed for 2 minutes. Add the rest of the liquid and beat for 2 minutes longer. Sprinkle the remaining crumbly mixture on top. Bake in two (6 x 10 inch) pans at 350 degrees for 30 minutes.

\*I do not use buttermilk but rather make my own with 1 c. milk and 1 Tbsp. vinegar.

# Fifth Circuit Expands Workplace Discrimination Protections for Women under Title VII and the Pregnancy Discrimination Act

V&E Employment, Labor and OSHA Update E-communication, June 6, 2013

In EEOC v. Houston Funding II, Ltd., the Fifth Circuit ruled that discriminating against an employee "who is lactating or expressing breast milk" violates Title VII of the Civil Rights Act of 1964, as amended (Title VII), and the Pregnancy Discrimination Act of 1976 (PDA). The case will now be remanded to the trial court for a jury trial.

By holding employers covered by Title VII and the PDA liable for harassment, termination of employment, or other adverse employment actions taken against an employee because she is lactating or expressing breast milk, the decision complements — but does not adopt — the requirements of the Affordable Care Act to provide reasonable break times for an employee to express breast milk and a private place, other than a bathroom, to do so.

The Houston Funding decision is significant because it provides greater protections to new moms returning to work and could bring an uptick in discrimination claims when women express breast milk at work. The EEOC is also likely to look more closely at charges of discrimination brought by women alleging discrimination related to lactation or expressing breast milk.

The Fifth Circuit's decision is grounded in its determination that lactation, "the physiological process of secreting milk from mammary glands and ... directly caused by hormonal changes associated with pregnancy and childbirth," is a related medical condition of pregnancy for purposes of Title VII and the PDA. However, the court articulated no separate analysis for applying Title VII or the PDA to expressing breast milk, which is not in itself a physiological condition. Whether other circuit courts will address this distinction remains to be seen.

## **Texas Vaccine Requirements**

#### To Vaccinate or Not to Vaccinate...

The debate as to whether or not vaccines are safe has burned on for years. Some believe vaccines should be mandatory, while some believe it should be their choice.

However, are you aware that Texas has laws that require vaccinations? Did you know that there are exemptions to these mandatory vaccination laws? How about the exemptions to the exemptions?

Regardless of which side of the fence you're on when it comes to vaccines, or perhaps you're sitting on the fence, there is no debate that it is in your best interest to know the vaccine laws.

#### **Routine Vaccinations**

Texas requires that all children receive certain vaccines before they are allowed to attend school. "Each student shall be fully immunized against diphtheria, rubeola, rubella, mumps, tetanus, and poliomyelitis." –See <u>Tex. Educ. Code § 38.001(a)</u>

Hold on though, this isn't an exhaustive list because the law also says that "the Department of State Health Services may modify or delete any of the immunizations...or may require immunizations against additional diseases as a requirement for admission to any elementary or secondary school." —See <u>Tex. Educ. Code § 38.001(b-1)</u>

This is the list of <u>required vaccines for 2013-2014</u>, but each year DSHS issues a new list with new vaccines that are required for attendance. Also, if you want to view schedules of how vaccines will be implemented in the near future, see <u>25 Tex. Admin. Code § 97.63</u>. —See DSHS School and Child-Care Facility Website

Additionally, institutions of higher education may require students to receive these same vaccinations, may designate additional vaccines for students studying animal or human sciences, and may even mandate additional vaccines for any students during times of emergency or epidemic. —See Tex. Educ. Code § 51.933(a)-(b)

#### **Bacterial Meningitis Vaccine**

For new and transfer students, colleges now have a mandatory vaccine.

If you're age 22 or above (the cutoff was age 30), or if you are only enrolling in online or distance courses, then this vaccination requirement does not apply to you. For the rest of you new or transfer students, then you must show proof that you have "received a bacterial meningitis vaccination dose or booster during the five-year period proceeding..." the compliance date. -See Tex. Educ. Code § 51.0192

Also, students in 7th grade and up are required to receive this vaccine; however, there it is referred to as a "meningococcal" vaccine.

-See <u>25 Tex. Admin. Code § 97.63</u>

#### **Exemptions from Vaccinations**

#### –<u>Risk</u>

For school-aged children, if a licensed medical doctor signs an affidavit or certificate stating that the "immunization required poses a significant risk to the health and well-being of the applicant or any member of the applicant's family or household," then the student will be exempted from having to receive the vaccination.

-See Tex. Educ. Code § 38.001(c)(1)(A)

For college students, if a licensed medical doctor signs an affidavit or certificate stating that "in the physician's opinion, the vaccination required would be injurious to the health and well-being of the student," then the student will be exempted from having to receive the vaccination. —See Tex. Educ. Code § 51.9192(d)(1)

#### -<u>Conscientious or Religious</u>

For school-aged children and college students, the method for achieving this exemption is the same. Unfortunately, it appears that the only way to achieve this is through making a formal application through DSHS and registering the name of the individual requesting the exemption, along with their address and birth date.

-See <u>Request for Affidavit for Exemption of Immunization</u> -See <u>Tex. Health & Safety Code § 161.0041</u>

This method takes several weeks to accomplish as the request has to be sent to Austin, TX, and then Austin must return this unique form to the applicant. This form may not be duplicated as it is printed on specialized paper and contains unique identification numbers and security devices to prevent it from being photocopied.

Once the applicant receives this form from Austin, then it must be signed in front of a Notary Public, which includes a statement that the applicant understands and filed with the school or college of the student no later than 90 days after being notarized.

-See Tex. Educ. Code § 51.9192(d-1)

#### The Fallout from Conscientious or Religious Exemptions

For students that are exempted from receiving vaccines based on conscientious or religious reasons are subject to additional limitations.

Elementary and Secondary students who have not received vaccinations "for reasons of conscience, including because of the person's religious beliefs, may be excluded from school in times of emergency or epidemic declared by the commissioner of public health." –See Tex. Educ. Code § 38.001(f)

Now for the scary part. For college students who receive an exemption from the bacterial meningitis vaccine for a conscientious or religious reason, this exemption "<u>does not apply during a disaster or public</u> <u>health emergency, terrorist attack, hostile military or paramilitary action, or extraordinary law</u> <u>enforcement emergency declared by an appropriate official or other authority and in effect for the</u> <u>location of the institution the student attends.</u>"</u> –See Tex. Educ. Code § 51.9192(d)(2)

What is Networking?

Net'work'ing *n* I the developing of contacts or exchanging of information, as to further a career (Webster's New World Dictionary).

If you asked ten people what networking was, you might get ten different answers. A person's definition of networking depends on their use of this personal and professional activity. Whether you network to make new friends, find a new job, find a soccer team for your child or find the name of a great dentist, it is important to focus on networking as an exchange of information, contacts or experience.

Any connections that you make through networking can help build relationships of support and respect and can cause you to discover and create mutual benefits. This is a skill that no serious professional should be without. Here are some simple networking guidelines:

- Start with a purpose. You must define your objectives to know what you are looking for.
- Name tags are placed on your right shoulder to provide an easy sight-line when shaking hands with someone.
- Have an effective handshake. There is no "man's" handshake or a "woman's" handshake! You have probably been on the receiving end of a "limp fish" or a "bone-crusher" handshake. Practice your handshake to avoid giving one of these yourself.
- Be sure to introduce yourself.
  - ☆ State your name clearly: "Hello, my name is Patti Heaney. It's a pleasure to meet you."
  - ☆ Shake hands.
  - $\Rightarrow$  In ten seconds or less, state what firm you're with or what you do.
  - $\Rightarrow$  If appropriate, offer a business card and ask the other person for their card.

Networking can be a fun and easy way to enhance your career. It helps to know people in the same profession as you. If you don't know the local rules of a particular court or need to know whether the federal court still requires pleadings to be two-hole-punched, it's your tri-level connection that can help answer those questions. Don't be shy about emailing someone in Texas ALP or NALS and ask if they can help answer the question.

Networking isn't about the **quantity** of contacts – it's about the **quality** of contacts. It takes a personal investment to network. One crucial tip to your success is to remember to treat networking as simply an exchange of ideas, information and experience. Be generous in sharing **your** talents, experiences and ideas with others and always be respectful of those around you. Try to give before you expect to get, and you will develop a good network of friends who will always be glad to help you because you're one of them.


# Leadership



## Do You Want to Be Facebook Friends or Do You Want to Serve Me?

In Reed Smith's Global Regulatory Blog <u>this week</u>, Cynthia O'Donoghue breaks down a <u>Michigan state court</u> <u>decision</u> earlier this year where the judge permitted service via Facebook message.

O'Donoghue tells us that in this case, the foreign defendant, a website operator, did not have a valid registered address listed on their website. The plaintiffs filed a motion for substituted service and demonstrated to the judge that the email address listed on the defendant's domain registration was accepting emails and that this email address was listed as the contact information on the website's Facebook account. Service was deemed complete by the court when the plaintiffs filed a return of service that indicated both the email and Facebook message had been sent, O'Donoghue says.

She goes on to note that service by alternative means is permitted by U.S. law under the right circumstances and is also permitted by the <u>Hague Service Convention Article</u> in situations where the signatory state of the party being served does not object.


