

# **PETRE'S STORY**

My name is Petre Racu, and I am a proud American. My journey to America began in my childhood when I was dreaming that one day I would seeing those "tall buildings" and brightly lit streets they were showing on TV. My dream laid dormant until my first year of college, which is when my desire to come to America came back to life. With some advice from my older brother and some financial help from my mother I managed to obtain a Visa for a program called "Summer Work and Travel."



The summer of 2011 was the first time I stepped foot on American soil and, man, what a summer that was! I worked, I travelled, and I also met the love of my life, my wife. It all felt so real but was so short lived that by the end of the summer when it was time to go back, I found myself confused and changed in ways that I could not comprehend. The short-lived dream had come to an end and it was time to go home. My wife (girlfriend at the time) and I said our goodbyes, and I flew back to Romania.

That's when I realized that I couldn't, nor did I want to, let go of this so easily. Now it was more than just a dream, now I knew this was real and it was where my heart was. Soon, my wife and I started putting together a plan to bring me back. I was in my second year of college in Romania when I decided that it might be easier for both of us if I transferred to Texas Tech and continued my studies there, knowing that I would be with her. Well, that didn't work out because my Visa was rejected, and I was back to square one. I kept reminding myself what has helped me get through obstacles since an early age: if you believe in something strong enough, it will happen.

My wife and I decided to get married the next year, and two years after that I was done with school. That same year I had gotten my green card, and I was able to fly back; that was during the summer of 2014. I had been working various jobs in Romania in the meantime, and I was off school for a whole year trying to get my paperwork in order. When my Student Visa got rejected in 2012, I took a break from school and moved to Bucharest, the capital of Romania, so I could be within driving distance of the American Embassy, making it easier to work on my case. When it was all done, I was able to fly back to Texas. In my heart I felt a joy that I had been missing for too long. It felt good to be back!

Slowly my wife and I started creating our little nest, and just kept improving it ever since. My Visa was conditional, so I would periodically have to check in with USCIS to get fingerprinted and have my information updated. The process went on for about five years which finally, this year, on October 15, I was naturalized.

It was a cold rainy day in Irving, Texas. The atmosphere was solemn, the room was filled with people. People from all parts of the world, people like me, pursuing a dream. The consular officer who made the introduction addressed us based on the country we were representing. By looking in the eyes of the people who were in the room with me, I could see something that was awfully familiar. It all made sense now. That spark in their eyes, that desire for a new and better future, is something that I have seen many times looking in the mirror as a child. We were all looking for a new beginning, a place where our past obstacles had ended, and we were moving on to a new chapter of our lives.

Know all who read this narrative that Waco Legal Professionals Association successfully added a new student member to its roster as a result of the membership drive held at McLennan Community College in October. # COMMITTEE DUTIES

**AWARDS:** coordinate Texas ALP Scholarship and LPY awards presented at Annual Conference. Work with host chapter for conference to obtain judges for awards.

**BYLAWS/STANDING RULES:** review bylaws and standing rules for necessary changes and maintain conformance with NALS bylaws/standing rules. Issue call for proposed amendments and furnish proposed amendments to EC. Provide proposed amendments to Secretary for distribution with the Call to Annual/ Fall Educational Conferences.

**CERTIFICATION:** answer all inquiries re: NALS certification programs and promote certification by providing articles for *The Texas Docket*. Work with Marketing to furnish press releases for those passing certification exams or recertifying. Work with host chapter to recognize members successfully completing exams during Recognition Luncheon.

**COMMUNICATIONS:** responsible for e-mail dissemination of official business. Maintain official roster and mini-roster. Obtain current rosters of officers from local chapters and provide them to NALS Resource Center. Coordinate (w/Treasurer) list of members eligible to vote--Treasurer will certify and submit to Nominations and Elections Chair.

**EDUCATION:** plan and coordinate legal education seminars sponsored by Texas ALP. Prepare CLE certificates for each meeting and work with host chapter to obtain speakers. Encourage local chapters to plan legal education study courses and provide assistance when asked. Provide education articles for each issue of *The Texas Docket*. Work with Marketing Committee to promote seminars, official courses, and educational materials.

**FINANCIAL REVIEW:** review financial records of the Treasurer, Fundraising Committee, and Fall and Annual Conferences, verify all receipts and disbursements, and provide financial review report covering such books to the EC and at Board and Annual Meetings.

**FUNDRAISING:** devise ways and means of raising funds. Develop and market Texas ALP logo items approved by the EC and make items available for purchase at all functions. Coordinate and promote Texas ALP raffles.

**TALP Hugs:** Receives and distributes requests for support from members and friends of TALP on a strictly voluntary opt-in/opt-out basis from a distribution list maintained specifically by and for TALP Hugs.

**MARKETING:** assist Membership in marketing and advertising benefits of membership. Develop and maintain promotional packets for distribution to local bar associations and local chapters as well as the Texas ALP brochure. Work with Certification to announce names of people passing certification

exams and recertifying. Work with host chapters to provide press releases about each Texas ALP function and assist local chapters with their Day-In-Court observance events. Promote all seminars and events and provide materials for publication in *The Texas Docket*.

**MEETINGS COORDINATOR:** encourage and assist local chapters to bid to host board or annual conferences. Act as coordinator between the President, EC, applicable chairmen, and hosting chapter in implementing scheduled conferences. Prepare and keep current the Guidelines for Bidding an Educational Conference and Guidelines for Planning an Educational Conference.

**MEMBERSHIP:** receive and promptly answer inquiries about membership. Develop, implement, and evaluate membership campaigns approved by Texas ALP. Act as liaison with local chapter membership chairmen. Assist Marketing with promoting and marketing benefits of membership. Submit articles and membership campaign information for publication in *The Texas Docket*.

**NOMINATIONS & ELECTIONS:** issue the call for officer nominations. Obtain consents to run from officer nominees, prepare and update candidate profile forms, and provide profile forms and photos to Webmaster. Work with BallotBox on elections and surveys. Responsible for announcing newly elected officers after certifying election results with President. Prepare ballots and teller reports for use at board and annual conferences.

**PLANNING COMMITTEE:** Monitor and update strategic plan annually and help facilitate planning process through consultation with Treasurer and EC about funds available for implementation. ## DEADLINE: February 13, 2019

A. A Legal Professional of the Year award shall be presented at the Annual Conference each year. Any member in good standing of the Texas Association of Legal Professionals who has *at least five (5) years* of legal experience is eligible to compete for the award.

B. Each local chapter has the privilege of sponsoring one applicant, who may or may not be the current winner of that local chapter's Legal Professional of the Year award. Additionally, each member in good standing may nominate one member as Legal Professional of the Year. Only one nomination will be considered for each nominee. In the event of multiple nominations, the first nomination received by the Awards Chair will determine the nomination form to be considered and submitted to the judges.

- C. (1) All entries must be submitted on the Texas ALP nomination form (or a photocopy thereof).
  - (2) All entries *must* be submitted in *duplicate* to the Awards Chair. If additional space is needed to complete any section, the back of the nomination form should be used.
  - (3) Observance of the 300-word limit specified under "Comments by Present Employer" and "Comments by Local Chapter" or "Comments by Nominating Member" and observance of the 300-word limit specified under "Nominee Narrative" is required. If the Awards Chair finds that the material in these sections contains the use of numbers, the most current edition of *The Gregg Reference Manual* will be the deciding authority on how numbers will be counted in the tabulation of the word limit specified. The use of "and/or" will be counted as *two words* in the tabulation of the word limit specified. Nominations will be disqualified if material in these sections exceeds the 300-word limit.
  - (4) Except for the "Comments by Present Employer" and "Comments by Local Chapter" or "Comments by Nominating Member," the NOMINEE MUST PERSONALLY COMPLETE THE NOMINATION FORM.
- D. No testimonial letters or other supporting documents will be considered by the judges. {TALP//00365450} Effective June 2018

Effective June 2018 Page 1 E. All nominees will be judged on the following basis:

Legal skills and experience40%
Service to local, state, and national associations40%
Personal Interview

- F. The Awards Chair shall select three judges and two alternate judges to assist in the judging of the LPY competition. The names of such judges will be presented no later than January 15 to the Executive Committee for approval. Selection of the three LPY finalists and two LPY alternates will be made by the three judges (or alternate judges, if necessary).
- G. To be eligible for judging, all entries must be hand delivered to the Awards Chair by no later than February 13, postmarked by the United States Postal Service on or before February 13, or validated by an overnight delivery service that such parcel was placed in such service's depository on or before February 13, and received by the Awards Chair on or before February 20. The Awards Chair will disqualify any nominations not validated as specified above or received after February 20. FAXED NOMINATION FORMS WILL NOT BE ACCEPTED.
- H. Nominating local chapter or nominating member should send an email to the Awards Chair stating the Texas ALP Nomination form has been sent in accordance with the Guidelines and Rules. Once the Awards Chair has received the Texas ALP Nominating Form, she will confirm receipt via email to the nominating local chapter or the nominating member.
- I. The Awards Chair shall submit redacted copies of all qualified entries to the judges no later than February 27. The name of the candidate, the candidate's address, and the name of the local chapter or nominating member are to be redacted from each entry sent to the judges.

As soon as the judges have made their decision, the Awards Chair will, no later than March 20, notify each of the three finalists by telephone and first class mail and notify the two alternates by certified mail. The finalists will be furnished a copy of the information form to be completed by the finalists, which completed forms will be given to *The Texas Docket* Editor after official announcement of the finalists at the Annual Conference. In the event any finalist is unable to attend the Annual Conference, an alternate, selected by the judges, will be invited to attend, and thus will become a finalist.

The identity of the three finalists will be kept confidential by the Awards Chair, Texas ALP President, and the finalists themselves until the three finalists are announced by the Awards Chair.

- J. The Awards Chair will acknowledge receipt of each nomination received. The Awards Chair will further, by either official report or direct mail, notify the local chapters whose entries have been disqualified, giving the reason(s) for disqualification.
- K. The judges shall conduct a personal, private interview with each of the three finalists at the Annual Conference, and thereafter each judge will individually and independently rate the three finalists according to the criteria given. The judges and the Awards Chair will then compile the results and determine the winner. The three finalists will be introduced and the winner announced at the Annual Conference.

The finalists' scores from paragraph E above will be carried forward and used as part of the scoring to determine the winner. During the interview, the finalists will be further judged on the basis of the following categories and the results recorded on a second rating sheet:

- Neatness of appearance
- Poise
- Personality
- Ability to converse

The finalist receiving the highest overall rating from both the initial scoring and the personal interview will be selected as the Legal Professional of the Year. In case of a tie, the judges will re-evaluate each finalist, giving further consideration to both rating areas, and will make a final decision.

- L. A nominee will be disqualified if the nominee, or anyone else on the nominee's behalf, contacts any of the judges personally, in writing, or by telephone.
- M. (1) The rating sheets used by the judges are considered to be **CONFIDENTIAL**. After the judging of the nominees has commenced, the information on the rating sheets will be viewed only by the President, the Awards Chair, and the judges.
  - (2) The final tabulation sheet prepared by the Awards Chair from the individual rating sheets of the judges will be signed and dated by all three judges and the Awards Chair following the final interviews at the Annual Conference. The President will approve and attest to the scoring and will sign and date the final tabulation sheet.
  - (3) At no time will the rating sheets or final tabulation form be duplicated for any nominee, finalist, or chapter for any purpose.
  - (4) At the close of the Annual Conference, *all* rating sheets, evaluation forms, judges' notes, etc., and the final tabulation form will be sealed in an envelope by the Awards Chair and delivered to the President for destruction.




