PURPOSES

- To further the knowledge of law and to uphold its honor and dignity.
- To stimulate a high order of business and professional attainment.
- To establish good fellowship among the members of the Texas Association of Legal Professionals.
- To further the interests of legal support professionals through such local associations in carrying out the objectives and purposes of the Texas Association of Legal Professionals and NALS.

CODE OF ETHICS

Each member of the Texas Association of Legal Professionals is required to subscribe to the Code of Ethics of NALS, as follows:

Members of NALS are bound by the objectives of this Association and the standards of conduct required of the legal profession.

Each member shall:

- Encourage respect for the law and the administration of justice.
- Observe rules governing privileged communications and confidential information.
- Promote and exemplify high standards of loyalty, cooperation, and courtesy.
- Perform all duties of the profession with integrity and competence.
- Pursue a high order of professional attainment.

TEXAS ALP HISTORY

The Texas Association is steeped in history. We can't begin to understand our association unless we begin with a brief history of NALS. NALS was founded in 1934 as the California Federation of Legal Secretaries. Later, in July 1940, it was incorporated under the name of Legal Secretaries, Incorporated. That name was changed to the National Association of Legal Secretaries when it was incorporated in California on August 1, 1950. In 1994 NALS Oklahoma, Inc., was formed, and the California and Oklahoma corporations were merged, with the surviving corporation being the National Association of Legal Secretaries, Inc. In 1999, at the urging of its members, the name changed once again, and our national association is now known simply as NALS . . . *the association for legal professionals*.

NALS issued Charter No. 2 to the Dallas Association of Legal Secretaries on November 2, 1952, and just 27 days later, on November 29, 1952 the Fort Worth Legal Secretaries Association received Charter No. 3. A charter was issued to Hutchinson County Legal Secretaries Association on February 26, 1953, and on November 20, 1953, Nueces County Legal Secretaries Association received its charter.

THE BEGINNING

On May 27, 1955, 41 modern day pioneers saw a need and accepted the challenge. With an idea and a common goal, they came from Hutchinson and Nueces Counties, Dallas, and Fort Worth to meet at the Driscoll Hotel in Corpus Christi, Texas, to form the foundation of the Texas Association of Legal Secretaries.

LaNell Hunt of Austin attended as a visitor.

This was a group with a mission, and they didn't hesitate to start the Texas Association of Legal Secretaries on the road to reality. Ruby Poole of Nueces County LSA called the meeting to order and was elected temporary chairman. Since no provision had been made for voting by delegates, a motion was made and adopted permitting all members present to vote. The first order of business was to appoint a bylaws committee and a nominating committee. Bylaws were submitted and adopted by the members present. The nominating committee presented a slate of officers to the membership, and the following members were unanimously elected as the *charter* officers of Texas ALS:

The officers were installed by Jess Lee Tucker of Fort Worth. A charter was issued to the Texas Association of Legal Secretaries on July 20, 1956.

Thus began a legacy that has spanned 55 years and is still growing.

IMPORTANT FACTS

EMBLEM AND BANNER

The original Texas Association emblem consisted of an outline of the state of Texas with the scales of justice, a quill, and the name Texas ALS, and has been used since the organization of the Texas Association until the name change in 2003. In 1969 the Texas Association banner was designed by Dorothy Mangum, PLS (Dallas ALS), and Georgia Sanders (Taylor County LSA). The banner was redesigned in 1993. The Texas ALS emblem was officially registered with the Secretary of State, Trademark Division, in 1970, with the renewal of the registration being made every ten years. In 2002 Larry Phelps (honorary member of Houston ALS) donated new banners. When the name of the Texas Association was changed to the Texas Association of Legal Professionals in 2003, the emblem was changed to reflect the name change and new banners were again donated by Larry Phelps, who was elected as an honorary member of Texas ALP at the Forty-eighth Annual Meeting.

DAY IN COURT

By Resolution No. 569, adopted by the Texas Legislature in 1969, the second week in October was officially designated “Legal Secretaries Week in Texas.” During this week, local associations plan various activities which allow their members, legal support professionals and students to observe firsthand the procedures and functions of the courts.

TEXAS ALS SPECIAL EDUCATION FUND

The Texas ALS Special Education Fund was established in 1970 by a gift from an anonymous donor. This fund was maintained by gifts and contributions from members, nonmembers, and profits from various projects sponsored by Texas ALS. The Texas ALS Special Education Fund was used to fund scholarships and for educational programs which were awarded annually for members and nonmembers. This fund was discontinued in 1990.

TEXAS ASSOCIATION SCHOLARSHIP PROGRAM

Realizing that we were in a position to encourage and assist young people in the pursuit of a legal career, our members established a scholarship fund in 1969 which has enabled young people to pursue their dream of entering the legal field. The Texas Association awarded its first scholarship in 1969 to Draughon’s Business College. Scholarships were

The scholarship was awarded annually from the Special Education Fund until the Fund was discontinued in 1990 and became a line item on the yearly budget. Scholarships are now awarded annually to recipients chosen from nominees submitted by the local chapters.

In 1996, after the loss of a very special member, Dorothy Mangum, PLS (Dallas ALS), a special one-time fund was established to offer a scholarship in Dorothy's name. At the annual meeting held in El Paso, Texas, Hay Myong "Marty" Kang was awarded the Dorothy Mangum Scholarship.

TEXAS LAW OFFICE HANDBOOK

In 1957, under the direction of Connie Parmelee of Fort Worth, the members of the Texas Association compiled and published the *Legal Secretary's Handbook (Texas)*. This loose-leaf handbook was made available to members and others engaged in legal work. The *Handbook* was published by Bancroft-Whitney. During 1969 and 1970 the *Handbook* was completely revised and expanded and renamed *Texas Law Office Handbook*, which was supplemented biannually. The first edition of the *Texas Law Office Handbook* was edited and coordinated under the supervision of Dorothy E. Mangum, PLS. Members of the Texas Association, lawyers, and educators contributed their efforts to the preparation and publication of the *Texas Law Office Handbook*.

The second edition of the *Texas Law Office Handbook* added several new topics. Cumulative supplements to the second edition of the *Texas Law Office Handbook* were compiled in 1984 and 1986.

In 1988 it was decided that the format of the *Texas Law Office Handbook* should be changed to a loose-leaf notebook style, and a contract was negotiated with Parker-Griffin Publishing Co. in Carlsbad, California, and work began revising and rewriting the *Texas Law Office Handbook*. Each chapter was reviewed and edited or rewritten by an attorney or educator with expertise in that area. One new chapter entitled "Intellectual Property" was added. The third edition of the *Texas Law Office Handbook* was published in June of 1990 and was featured at Parker-Griffin Publishing Co.'s display at the NALS 1990 annual meeting in Philadelphia, Pennsylvania. The *Handbook* was reviewed, updated, and revisions published each year until 1996, when the membership voted to abandon the project.

TEXAS ALS OFFICIAL COURSE

Always involved with education, in 1973, Texas ALS compiled and developed the Texas ALS Official Course. This is a study course using the *Texas Law Office Handbook* as the text. A study-guide workbook was available, as was a teacher's manual for the instructor. An official examination was given at the completion of the course.

The third edition of the *Texas Law Office Handbook* was used as the source reference for a series of seminars throughout Texas in 1990. The *Handbook* was discontinued in 1996.

LEADERSHIP

During the 1986–1987 NALS fiscal year, the member states were invited to send two representatives to attend a leadership workshop. One of the two representatives who attended on behalf of the Texas Association was Beth Walker, PLS, CLA. This invitation was issued again in 1987–1988, and Beth Walker, PLS, CLA, and Donna Dendy, PLS, CLA, attended as representatives of the Texas Association.

From this second meeting, the Texas Association decided to form a leadership team for the purpose of developing leadership training workshops to be presented at Texas Association meetings and also to develop programs to be presented for local chapter workshops. Judith Smith, PLS, CLA, became a member of the leadership team during 1988–1989.

Our leadership program was recognized by NALS in 1992 when the members of the Texas leadership team became the “NALS Leadership Team.” What a tribute to the leadership capabilities of Texas members! In 1996 the Texas leadership program won the nationally acclaimed Keystone Award.

The faces of our leadership team have changed over the years, but the team continues to provide various programs designed to assist Texas Association members and chapters in developing both personal and professional performance skills.

LONG-RANGE PLAN

In 1989 the Texas Association realized that in order to meet the needs of the future, a long-range plan had to be developed and implemented. Druann Wiley, PLS (Beaumont LSA), was chosen as the first chair of the Long-Range Planning Committee, and she and her committee members began the process of developing a plan for Texas. Many of the goals from that first long-range plan have been met. Today, to meet the ever-changing needs of our members and to insure the stability of the Texas Association, the long-range plan has been periodically modified and revised. With the 2003–2004 board, the Long-Range Planning Committee was changed to a standing committee and renamed the Strategic Planning Committee to reflect the current times. In 2003-2004, a new Strategic Plan was adopted, including the mission statement - “Texas Association of Legal Professionals is committed to providing education, certification, and professional and personal development to all legal professionals.”

THE TEXAS DOCKET

The *Texas Docket* has been described as the flagship of the Texas Association. It is a legal education magazine published quarterly and furnished to all members of the association. This publication provides legal education articles for the members and keeps them informed of activities of our association. In NALS competitions, the *Texas Docket* won first place in 1966, second place in 1970, first place in 1971, fourth place in 1980, and first place in 1982. With the implementation of the NALS Foundation Jett Awards, the *Docket* won the Keystone Award in 1996, and the Cornerstone Award in 2004.

HIGHLIGHTS

Our written history unfortunately contains gaps. In updating our history, it was decided to include a section entitled *Highlights*, which is designed to touch briefly on the past years. Updating the history of the Texas Association is the responsibility of each Recording Secretary. Any deletion is unintentional, as the highlights are at the writer’s discretion.

Pre-Organization

The following chapters were chartered before the organizational meeting of Texas ALS: Dallas ALS (chartered November 2, 1952), Fort Worth LSA (chartered November 29, 1952), Hutchinson County LSA (chartered February 26, 1953), and Nueces County LSA (chartered November 20, 1953).

1955 (Organizational Meeting)

The organizational meeting of the Texas Association of Legal Secretaries was held in Corpus Christi, May 28–29, 1955. Catherine Mitchon (Nueces County) was elected as the first president of the Texas Association, along with Ellen French (Hutchinson County) as First Vice President, Judy Carter (Dallas) as Second Vice President, Joyce Holcomb (Hutchinson County) as Recording Secretary, Mildred Smith (Nueces County) as Corresponding Secretary, and Marilyn Rine (Fort Worth) as Treasurer. Jess Lee Tucker of Fort Worth was the installing officer.

1955-1956

On January 25, 1956, Houston ALS's charter was issued by NALS.

The 1st Annual Meeting was held in May 1956 in Fort Worth (hosted by Fort Worth LSA), and Judy Carter (Dallas) was installed as the second president of the Texas Association.

1956-1957

The First Board Meeting was held in Fort Worth in May 1956 and presided over by President Judy Carter.

On September 22, 1956, Waco LSA's charter was issued by NALS.

On March 20, 1957, Amarillo LSA's charter was issued by NALS.

On May 16, 1957, Bell County LSA's charter was issued by NALS.

The 2nd Annual Meeting was held in May 1957 in Borger (hosted by Hutchinson County), and Elena Rapp, PLS (Fort Worth) was installed as the third president of the Texas Association.

1957-1958

The First Board Meeting was held in Borger in May 1957 and presided over by President Elena Rapp, PLS.

On June 7, 1957, San Antonio LSA's charter was issued by NALS.

On March 1, 1958, Lubbock LSA's charter was issued by NALS.

In April 1958 Elaine Talley and another legal secretary organized Wichita County LSA after reading an article in a legal publication about NALS and contacting Clara Lagow, then NALS President.

The 3rd Annual Meeting was held in May 1958 in Waco (hosted by Waco LSA), and Kitty Hawthorne (Waco) was installed as the fourth president of the Texas Association.

1958-1959

The First Board Meeting was held in Waco in May 1958 and presided over by President Kitty Hawthorne.

On July 7, 1958, Wichita County LSA's charter was issued by NALS.

Elena Rapp, PLS (Fort Worth) was chosen NALS 1958 Legal Secretary of the Year.

On October 15, 1958, Anderson County LSA's charter was issued by NALS.

The 4th Annual Meeting was held in May 1959 in Houston (hosted by Houston ALS), and Irene Morton (San Antonio) was installed as the fifth president of the Texas Association.

1959-1960

The First Board Meeting was held in Houston in May 1959 and presided over by President Irene Moorton.

On July 23, 1959, Pampa ALS's charter was issued by NALS.

Elizabeth Rast (Waco) was chosen NALS 1959 Legal Secretary of the Year.

On January 18, 1960, Tyler LSA's charter was issued by NALS.

On February 23, 1960, Alice LSA's charter was issued by NALS.

The 5th Annual Meeting was held in May 1960 in San Antonio (hosted by San Antonio LSA), and Florence Sandy (Houston) was installed as the sixth president of the Texas Association.

1960-1961

The First Board Meeting was held in San Antonio in May 1960 and presided over by President Florence Sandy.

On June 20, 1960, Beaumont LSA's charter was issued by NALS.

On June 26, 1960, Texarkana LSA's charter was issued by NALS.

On October 20, 1960, Orange County LSA's charter was issued by NALS.

On October 28, 1960, Austin LSA's charter was issued by NALS.

On November 7, 1960, Port Arthur LSA's charter was issued by NALS.

On February 20, 1961, Brownwood LSA's charter was issued by NALS.

The 6th Annual Meeting was held in May 1961 at the Baker Hotel in Dallas (hosted by Dallas ALS), and Elizabeth Rast (Waco) was installed as the seventh president of the Texas Association.

1961-1962

The First Board Meeting was held in Dallas in May 1961 and presided over by President Elizabeth Rast.

On May 25, 1961, Odessa LSA's charter was issued by NALS.

On June 23, 1961, Bosque-Commanche-Coryell-Hamilton Counties LSA's charter was issued by NALS.

On June 28, 1961, Athens LSA's charter was issued by NALS.

On July 23, 1961, Jasper LSA's charter was issued by NALS.

On September 8, 1961, Midland LSA's charter was issued by NALS.

On February 26, 1962, Gregg County LSA's charter was issued by NALS.

On April 10, 1962, Mount Pleasant LSA's charter was issued by NALS.

On April 19, 1962, Grand Prairie LSA's charter was issued by NALS.

The 7th Annual Meeting was held in May 1962 in Lubbock (hosted by Lubbock LSA), and Elaine Talley (Wichita County) was installed as the eighth president of the Texas Association.

1962-1963

The First Board Meeting was held in Lubbock in May 1962 and presided over by President Elaine Talley.

On June 28, 1962, San Angelo LSA's charter was issued by NALS.

On July 20, 1962, Galveston LSA's charter was issued by NALS.

On October 28, 1962, Howard County LSA's charter was issued by NALS.

On January 10, 1963, Plainview LSA's charter was issued by NALS.

On February 6, 1963, El Paso County LSA's charter was issued by NALS.

On April 8, 1963, Taylor County LSA's charter was issued by NALS.

On April 25, 1963, Kermit LSA's and Mitchell-Nolan Counties LSA's charters were issued by NALS.

The 8th Annual Meeting was held in May 1963 in Austin (hosted by Austin LSA), and Mildred Garner (Bell County) was installed as the ninth president of the Texas Association.

1963-1964

The First Board Meeting was held in Austin in May 1963 and presided over by President Mildred Garner.

On October 12, 1963, Pecos LSA's charter was issued by NALS.

On November 1, 1963, Scurry County LSA's charter was issued by NALS.

On November 30, 1963, Ward County LSA's charter was issued by NALS.

On February 2, 1964, Fort Stockton LSA's charter was issued by NALS.

The 9th Annual Meeting was held in May 1964 in Midland (hosted by Midland LSA), and Janette Sydow (Beaumont) was installed as the tenth president of the Texas Association.

1964-1965

The First Board Meeting was held in Midland in May 1964 and presided over by President Janette Sydow.

On November 11, 1964, Levelland LSA's charter was issued by NALS.
On February 3, 1965, Longview LSA's charter was issued by NALS.
The 10th Annual Meeting was held in May 1965 in Houston (hosted by Houston ALS), and Irene Fox Nilan, PLS, CLA (Fort Worth), was installed as the eleventh president of the Texas Association.

1965-1966

The First Board Meeting was held in Houston in May 1965 and presided over by President Irene Fox Nilan.
On June 18, 1965, Hidalgo County LSA's charter was issued by NALS.
On January 10, 1966, Harrison County LSA's charter was issued by NALS.
On January 21, 1966, Brazos County LSA's charter was issued by NALS.
On February 18, 1966, Panola-Shelby Counties LSA's charter was issued by NALS.
On March 31, 1966, Calhoun-Victoria Counties LSA's charter was issued by NALS.
On April 2, 1966, Denton County LSA's charter was issued by NALS.
The 11th Annual Meeting was held in May 1966 in Fort Worth (hosted by Fort Worth LSA), and Bernice Hightower Smith, PLS (Tyler), was installed as the twelfth president of the Texas Association

1966-1967

The First Board Meeting was held in Fort Worth in May 1966 and presided over by President Bernice Hightower Smith.
On April 1, 1967, Andrews-Gaines Counties LSA's charter was issued by NALS.
Texas ALS won third place in the NALS history book competition.
The 12th Annual Meeting was held in May 1967 in Corpus Christi (hosted by Nueces County LSA), and Mildred Barton (Houston) was installed as the thirteenth president of the Texas Association.

1967-1968

The First Board Meeting was held in Corpus Christi in May 1967 and presided over by President Mildred Barton.
On September 15, 1967, Del Rio LSA's charter was issued by NALS.
On April 14, 1968, Laredo LSA's charter was issued by NALS.
The membership of Texas ALS rose to 1,001 during 1967-1968.
The 13th Annual Meeting was held in May 1968 in Waco (hosted by Waco LSA), and Dorothy Cullison (Fort Stockton) was installed as the fourteenth president of the Texas Association.

1968-1969

The First Board Meeting was held in Waco in May 1968 and presided over by President Dorothy Cullison.
On June 3, 1968, Cameron County LSA's charter was issued by NALS.
Texas ALS won First Honorable Mention in the NALS history book competition.
On September 19, 1968, El Paso County LSA's charter was issued by NALS.
On November 12, 1968, Nacogdoches County LSA's charter was issued by NALS.
On December 19, 1968, Falls County LSA's charter was issued by NALS.
On February 3, 1969, Hays-Comal Counties LSA's charter was issued by NALS.
On April 3, 1969, Hopkins County LSA's charter was issued by NALS.
The 14th Annual Meeting was held in May 1969 in Lubbock (hosted by Lubbock LSA), and Georgia Sanders (Taylor County) was installed as the fifteenth president of the Texas Association.

1969-1970

The First Board Meeting was held in Lubbock in May 1969 and presided over by President Georgia Sanders.
On May 24, 1969, Mesquite LSA's charter was issued by NALS.

Julianna D. Parr, PLS, CPS (Nueces County), was selected as the NALS 1969 Legal Secretary of the Year. The NALS Convention was held in Detroit, Michigan.

On August 9, 1969, Hunt County LSA's charter was issued by NALS.

The 15th Annual Meeting was held in May 1970 in Austin (hosted by Austin LSA), and Dorothy Mangum, PLS (Dallas), was installed as the sixteenth president of the Texas Association.

1970-1971

The First Board Meeting was held in Austin in May 1970 and presided over by President Dorothy Mangum, PLS.

On March 27, 1971, Hardin County LSA's charter was issued by NALS.

The State Bar of Texas held its Second Annual Legal Secretaries Institute in Arlington. The Texas ALS PLS Cram Test for PLS study became a reality. The Texas ALS emblem was officially registered with the Secretary of State. Texas ALS won third place in the NALS history book competition, and the TALS Docket won second place in the state bulletin competition.

The state membership total was 1,341.

The 17th Annual Meeting was held in May 1972 in Dallas (hosted by Dallas ALS), and Kathleen T. Payne (Fort Worth) was installed as the eighteenth president of the Texas Association.

1972-1973

The 32nd Annual Meeting was held in May 1987 in San Antonio (hosted by San Antonio LSA), and Rhita Koches, PLS, CLA (Tyler), was installed as the thirty-third president of the Texas Association. The Second Board Meeting was held in Amarillo in September 1988.

The Third Board Meeting was held in Fort Worth in February 1989.

On April 6, 1989, North Dallas LSA’s charter was issued by NALS.

The NALS 1989 Spring Board Meeting was held in Cincinnati, Ohio.

Texas ALS conducted regional educational seminars in Houston, Dallas, and San Antonio, and the first of many National Director’s Forums was conducted. A contract was signed with a new publisher for a revised, loose-leaf format *Texas Law Office Handbook*.

The 34th Annual Meeting was held in May 1989 in Austin (hosted by Austin LSA), and Sandra K. Pfluger, CPS, PLS (Nueces County), was installed as the thirty-fifth president of the Texas Association.

1989-1990

The First Board Meeting was held in Austin in May 1989 and presided over by President Sandra K. Pfluger. The NALS Annual Meeting was held in Birmingham, Alabama.

The Second Board Meeting was held in South Padre Island (hosted by Cameron County) in September 1989.

The Third Board Meeting was held in Dallas (hosted by Dallas) in February 1990.

The 35th Annual Meeting was held in May 1990 in Beaumont (hosted by Beaumont), and Donna K. Dendy, PLS, CLA (Midland), was installed as the thirty-sixth president of the Texas Association.

1990-1991

The First Board Meeting was held in Beaumont in May 1990 and presided over by President Donna K. Dendy. The NALS Annual Meeting was held in Philadelphia, Pennsylvania.

On July 9, 1990, Greater Dallas LSA’s charter was issued by NALS.

The Second Board meeting was hosted by Arlington in September 1990.

The Third Board meeting was held in Corpus Christi in February 1991.

The new *Texas Law Office Handbook* was published after three years of planning and work. A Meeting Guidelines Task Force was begun. TALS conducted its first PLS Cram Weekend. The NALS Fall Board Meeting was held in Fort Worth, and the Texas ALS Leadership Team was asked to present the TALS formula for leadership success. The first comprehensive long-range plan was adopted. Texas ALS member Sandra Yost was elected NALS President.

The 36th Annual Meeting was held in May 1991 in El Paso (hosted by El Paso County), and Shirley Kuchar Smith, PLS (Greater Houston), was installed as the thirty-seventh president of the Texas Association. Also installed were the following elected and appointed officers: Cindy McElroy (First Vice President), Vickey Lee, PLS (Second Vice President), Aida G. Delgado, PLS, CLA (Recording Secretary), Jo Ann Brown, PLS (Treasurer), Amelda Perritt, PLS (Corresponding Secretary), Sandra K. Pfluger, CPS, PLS (National Director), and Judith Smith, PLS, CLA (Parliamentarian).

1991-1992

The First Board Meeting was held in El Paso in May 1991 and presided over by President Shirley Kuchar Smith.

The NALS Spring Board Meeting was held in Houston and hosted by Texas ALS. The TALS Leadership Team, now the NALS Leadership Task Force, was asked to make a presentation on how to make a public presentation (public speaking). The Team was introduced as a regular part of the NALS board meeting. Charter member Elizabeth “Libba” Rast (Waco) passed away on August 29, 1992. Libba served as the 1961–1962 President of Texas ALS and was a Life Member of Waco LSA.

The Second Board Meeting was held in Galveston, September 20–22, 1991, at the Tremont House. There were 160 members in attendance.

The NALS Fall Board of Directors Meeting was held in Richmond, Virginia, on October 19, 1991.

Treasurer Jo Ann Brown resigned her office following the Second Board Meeting when her husband was transferred to Aruba. Amelda Perritt, PLS, served as Treasurer and Aida G. Delgado, PLS, CLA, served as Recording Secretary/Corresponding Secretary for the remainder of the year following Jo Ann Brown’s resignation.

The Third Board Meeting was held in Tyler (hosted by Tyler), February 21–23, 1992, and the meeting theme was “Winning With TALS.”

The TALS Site Selection Committee was first appointed, with Dorothy Mangum serving as chair.

The highlight of the year was the investiture of Sandy Yost as NALS President and the election and investiture of Donna Dendy as Corporate Secretary in Chicago at the annual meeting.

The 37th Annual Meeting was held April 30–May 3, 1992, in Lubbock (hosted by Lubbock), and Cindy Boulton (Hunt County) was installed as the thirty-eighth president of the Texas Association. The following elected and appointed officers were also installed: Vickey Lee, PLS (President-elect), Aida G. Delgado, PLS, CLA (Vice President), Amelda Perritt, PLS (Recording Secretary), Joyce Look, PLS (Treasurer), Karen A. Perrin (Corresponding Secretary), Shirley Kuchar, PLS (National Director), and Sandra K. Pfluger, CPS, PLS (Parliamentarian). This was the first time for the office of President-elect, and the office of Vice President replaced the offices of First and Second Vice Presidents.

1992-1993

The First Board Meeting was held in Lubbock in May 1992 and presided over by President Cindy Boulton. The first TALS Continuing Education Council was appointed, a Financial Planning Task Force was established, and Texas ALS began approving its annual budget at the third board meeting each year. The first ALS short course was offered.

Denton County LSA member Joann Chisum Garbacik died June 4, 1992. Joann served Denton County as its

Greater Houston LSA member Helen LaKatos died September 24, 1992. Helen served as president of Miami (FL) LSA in 1964–1965 and was chosen Secretary of the Year in 1973. When she moved to Houston in 1975, Helen immediately became active in Houston ALS and became a charter member of Greater Houston LSA when it was formed in 1982, where she was given life member status in 1991.

Fort Worth member Carol Burns Watson passed away on February 12, 1993.

The Third Board Meeting was held in Dallas at the Marriott Park Central, February 26-28, 1993. This was the first nonhosted board meeting.

The NALS Spring Board of Directors Meeting was held in Houston on March 28, 1993.

The 38th Annual Meeting was held at the Corpus Christi Marriott Hotel in Corpus Christi (hosted by Nueces County) May 20–23, 1993, and Vickey D. Lee, PLS (Greater Houston), was installed as the thirty-ninth president of the Texas Association. The investiture was conducted by Installing Officer Beth Walker, PLS, CLA, with assistance from Installing Marshals Bud Maynard, Shirley Kuchar, PLS, and Sherry Maynard. The following elected and appointed officers were also installed: Aida Delgado, PLS, CLA (President-elect), Amelda Perritt, PLS (Vice President), Joyce E. Look, PLS (Recording Secretary), Karen A. Perrin (Treasurer), Becky Tanner, PLS, CPS, CLA (Corresponding Secretary), Druann Wiley, PLS, CLA (National Director), and Carol Bruehler, PLS, CLA, CPS (Parliamentarian). The scholarship recipient was Susie M. Sanchez (sponsored by El Paso County). The finalists for Legal Secretary of the Year were Sharon Z. Arway, PLS (Greater Houston LSA), Gina Marie Estrella, PLS (El Paso County LSA), and Ruby T. Higgins, PLS, CLAS (Fort Worth LSA). It was announced at the Presidents' Banquet that the finalist selected as Legal Secretary of the Year was Gina Marie Estrella, PLS (El Paso County LSA).

The year ended with 37 chapters and 1774 members, including 29 members-at-large and 30 secondary members.

1993-1994

The NALS Annual Meeting was held in New Orleans, Louisiana.

The Second Board Meeting was held at the Embassy Suites Hotel in Abilene (hosted by Taylor County), September 17–19, 1993.

The Third Board Meeting was held at the Houston Marriott West Loop by the Galleria in Houston (hosted by Greater Houston), February 18–20, 1994.

The 39th Annual Meeting was held at the Plaza San Antonio Hotel in San Antonio (hosted by San Antonio), May 19–22, 1994, with a total registration of 180. Bylaw and standing rule amendments passed allowing consideration of amendments at all meetings rather than only at the Annual Meeting. President Lee presented an award on behalf of Texas ALS at the Annual Meeting to Elsbeth Baskette, PLS (Houston ALS) for her many contributions to our trilevel association. Aida Delgado, PLS, CLA (San Antonio), was installed as the fortieth president of the Texas Association by Judith Smith, PLS, CLA, with assistance from Installing Marshals Dina Delgado-Kadletz, David Delgado, Joseph Bennetti, and Craig L. Austin, Esq. The following elected and appointed officers were also installed: Amelda Perritt, PLS (President-elect), Joyce E. Look, PLS (Vice President), Karen A. Perrin (Recording Secretary), Becky Tanner, PLS, CPS, CLA (Treasurer), Marjorie Lawrence, PLS (Corresponding Secretary), Vickey Lee, PLS (National Director), and Martha C. 1994-1995

The Third Board Meeting was held at the Wyndham Austin Hotel in Austin (hosted by Austin), February 17–19, 1995. TALS hosted a Professional Legal Secretary Educational Institute. The featured speaker for the Sunday morning Leadership Breakfast was Martha Whitehead, Treasurer of the State of Texas.

Donna Dendy was elected NALS President-elect in Tulsa in the spring.

The 40th Annual Meeting was held in Midland (hosted by Midland), May 18–21, 1995, with a meeting theme of “Wings Over the Oil Patch.” At the Annual Meeting, the following Legal Secretary of the Year finalists were announced: Ruby Higgins, PLS, CLA (Fort Worth LSA); Meri Nelson, PLS (Nueces County LSA); and Nancy Quirk (Arlington LSA). Special guests attend the Annual Meeting were Elaine Heape, PLS (President of Louisiana LSA), Mrs. William Brown (Texas Legal Directories Publishing Company), and Stan Orr, CAE (NALS Executive Director). A special presentation to Mr. and Mrs. William Brown of Texas Legal Directories Publishing Company was made for the 25 years of support and friendship begun in 1974 at the NALS Annual Meeting in Houston, Texas. Amelda Perritt, PLS (Fort Worth), was installed as the forty-first president of the Texas Association by Installing Officer Donna K. Dendy, PLS, CLA, with assistance from Installing Marshal Dennis Sheehan, Esq. The following elected and appointed officers were also installed: Joyce E. Look, PLS (President-elect), Karen A. Perrin, PLS (Vice President), Becky Tanner, PLS, CPS, CLA (Recording Secretary), Marjorie Lawrence, PLS (Treasurer), Kathie Jean Keys, PLS (Corresponding Secretary), Aida Delgado, PLS, CLA (National Director), and LaVoice Meier, PLS, CLA (Parliamentarian). The scholarship recipient was Valarie Marie Glassel (sponsored by Greater Houston). The finalists for Legal Secretary of the Year were announced during the Annual Meeting: Ruby T. Higgins, PLS, CLAS (Fort Worth), Meri Nelson, PLS (Nueces County), and Nancy Quirk (Arlington). It was announced at the Presidents' Banquet that the finalist selected as Legal Secretary of the Year was Ruby T. Higgins, PLS, CLAS (Fort Worth).

The year ended with 35 chapters and a total membership of 1650, plus 12 secondary members.

1995-1996

The First Board Meeting was held in Midland in May 1995 and presided over by President Amelda Perritt, whose theme revolved around positive attitudes. It was that positive attitude that helped to create the task force assigned to investigate the possibility of Texas ALS creating and implementing a specialty certification exam designed specifically for Texas law. Barbara Akins, PLS, served as the chairman of this committee until November 1997 when the first exam was administered.

The Texas ALS Leadership Committee held a leadership training seminar at the Seven Oaks Resort & Conference Center in San Antonio, August 19, 1995.

The Second Board Meeting was held at the Green Oaks Inn and Conference Center in Fort Worth, September 22–24 1995. A “Christmas in Cowtown” craft bazaar was sponsored by the Financial Planning Committee.

The Strategic Plan was adopted by the National Association, which implemented anniversary due dates. This plan also provided for NALS to collect all dues and distribute them to the state associations and local chapters.

Although she moved from Texas prior to being installed as NALS President, Texas still claims Sandy L. Yost, PLS, since she was a member of North Dallas ALS when she was elected President-elect.

Texas ALS 1970–1971 President Dorothy Mangum, PLS, died December 2, 1995.

The Third Board Meeting was held at the Marriott Arlington Hotel in Arlington (hosted by Arlington), February 2-4, 1996. In addition to the excellent seminars and the camaraderie, this meeting was especially noteworthy because of the weather—Arlington was covered in ice and snow!

The 41st Annual Meeting was held at the Radisson Resort South Padre Island in South Padre Island (hosted by Cameron County), May 16–19, 1996, with 135 full registrations, plus 12 member registrations, 14 student registrations, 3 nonmember registrations and 7 Past President registrations. At the PLS luncheon, Barbara Akins asked for and received \$1,000 to use for marketing the PLS in the *Texas Bar Journal*. During her report at the Annual Meeting as chair of the Specialty Certification Committee, Barbara Akins, PLS, moved that the delegates adopt the White Paper report as mailed to all chapters and that \$5,000 be committed to the development implementation of the program, which motion was passed. Ted D. Lee of Gunn, Lee & Miller, P.C. (San Antonio) was elected as an honorary member of Texas ALS. Joyce E. Look, PLS (Houston), was installed as the forty-second president of the Texas Association. The investiture was conducted by Installing Officer Vickey Lee, PLS, with assistance from Installing Marshals Marc Sony, Morton Look, and Shirley Kuchar Smith, PLS. The following elected and appointed officers were also installed: Karen A. Perrin, PLS (President-elect), Becky Tanner, PLS, CPS, CLA (Vice President), Majorie Lawrence, PLS (Recording Secretary), Kathie Jean Keys, PLS (Treasurer), Debbie Wheeler, PLS, CLA, TSC (Corresponding Secretary), and Amelda Perritt, PLS (National Director). The scholarship recipient was Carlos Moralez (sponsored by San Antonio LSA). The finalists for Legal Secretary of the Year were announced during the Annual Meeting: Sharon Coleman, PLS, CLA, CPS (Arlington LSA), LaNelle Douglass, PLS, CLA (Fort Worth LSA), and Judith S. Smith, PLS, CLA (San Antonio LSA). It was announced at the Presidents' Banquet that the finalist selected as Legal Secretary of the Year was Judith S. Smith, PLS, CLA (San Antonio LSA). (Vice President Becky's membership campaign theme was the Texas Triathlon.)

The year ended with 35 chapters and a total membership of 1372, plus 13 secondary members.

1996-1997

The First Board Meeting was held in South Padre Island on May 19, 1996, presided over by President Joyce Look, who encouraged each of us to “Choreograph Your Future With Texas ALS.”

The NALS Annual Meeting and Educational Conference was held in Nashville, Tennessee, July 26–31, 1996. Texas ALS's own Donna K. Dendy, PLS, CLA, took office as NALS President. Jett Awards were won by: *Keystone*—Texas ALS for the Leadership Training Program (category Chapter Enterprises, State Association); *Keystone*—Texas ALS for The Texas ALS Docket (category Chapter Development, State Association); and *Keystone*—Anderson County LSA for the PLS/ALS Study Group (category Certification Program PLS, Small Chapter).

Nationally, the year saw the adoption by NALS of the Restructure and Governance Plan. Under this new concept, the state position of National Director was eliminated and issues involving members' rights were given over to the members for ultimate determination. The idea of one member, one vote became a reality. Amelda Perritt, PLS (Fort Worth LSA), served Texas ALS as its last National Director.

The NALS membership was partitioned into regions, with each region having one elected director on the NALS board of directors. Texas, together with Louisiana, Mississippi, Missouri, Arkansas, and Oklahoma made up Region 6. In the true pioneer spirit, Texas member Joyce E. Look, PLS (Houston ALS), was elected the first Region 6 Director.

That year, in an effort to show our appreciation for the hospitality shown by the chapters hosting our meetings, President Joyce requested that each chapter select a charity to support during the respective board meetings. The members, in a testament to the generous spirit that it Texas ALS, brought donated items for each of the charities.

The Second Board Meeting was held at the Ambassador Hotel in Amarillo, September 20-22, 1996, with a registration of 104. The meeting was billed as a “jeans and boots and no business suits” meeting and was the first casual dress meeting. The Saturday night optional event was a “Cowboy Evening” on the rim of Palo Duro Canyon.

The Texas Association of Legal Secretaries was incorporated effective November 1, 1996.

The Third Board Meeting was held at the Red Lion Hotel of Houston in Houston (hosted by Houston ALS), February 13–16, 1997, with a registration of 122. A motion was made and carried at the board meeting to discontinue all present work on and efforts to publish the *Texas Law Office Handbook*. As chair of the Specialty Certification Committee, Barbara Akins, PLS, reported that the first sitting for the civil litigation exam will be in November 1997 in Houston and Austin. She also presented a motion to incorporate the Texas Institute for Specialty Certification, which carried.

The 42nd Annual Meeting and Educational Conference held at the El Paso Marriott in El Paso, May 15-18, 1997. Texas ALS paid tribute to Dorothy Mangum, PLS, as it awarded a one-time scholarship to Hay Myong “Marty” Kang in her memory. Medallion Awards were won by Fort Worth LSA (Court Observance Category, 41st Annual Day in Court) and Greater Houston LSA (Continuing Legal Education Category, An Alternative Legal Training Course; Marketing Category, Annual Report to the Membership; and Publications Category, Highlights). The three finalists for Legal Secretary of the Year were introduced: Tilde Belinke, PLS, CLA (Fort Worth LSA), Cindy Curry, PLS, CLA (Cameron County LSA), and Rebecca Lu Tanner, PLS, CPS, CLA (San Antonio LSA); with alternates being Sheryl A. Mann, PLS (Nueces County LSA), and Martha Richie, PLS (Lubbock LSA). Lorraine Brown (was elected as an honorary Member of Texas ALS. Karen Perrin, PLS (Dallam-Hartley-Moore-Sherman Counties), realized her dream when she was installed as the forty-third president of the Texas Association by installing Officer Sandra K. Pfluger, PLS, CPS. The following elected and appointed officers were also installed: Becky Tanner, PLS, CPS, CLA (President-elect), Kathie Jean Keys, PLS (Vice President), Debbie Wheeler, PLS, CLA, TSC (Recording Secretary), Faynell Poe, PLS (Treasurer), Julie A. Abernathy, PLS (Corresponding Secretary), and Joyce E. Looks, PLS (Parliamentarian). The finalists for Legal Secretary of the Year were announced during the Annual Meeting: Tilde Belinke, PLS, CLA (Fort Worth LSA), Cindy Curry, PLS, CLA (Cameron County LSA), and Rebecca Lu Tanner, PLS, CPS, CLA (San Antonio LSA). It was announced at the Presidents’ Banquet that the finalist selected as Legal Secretary of the Year was Cindy Curry, PLS, CLA (Cameron County LSA). (Vice President Kathie’s membership campaign theme was the Strategic Membership Plan.)

1997-1998

The First Board Meeting was held in El Paso on May 18, 1997, with President Karen presiding.

The Leadership Committee held a Texas ALS 8-Hour Workout in Dallas, June 21, 1997, geared to personal and chapter development, including coping with change, dealing with difficult people, integrity and competence, and officer and chairman workshops.

The year also saw a dark cloud appear on the NALS horizon. In July 1997, Judy Snider, PLS, NALS President, sent an urgent letter to the membership requesting financial assistance to help eliminate NALS’ outstanding debt. During the Second Board Meeting in Wichita Falls, the Texas ALS membership, in responding to the request, required that certain conditions be met before any financial assistance would be considered. During the Third Board Meeting in Plano, the membership agreed to lend its financial support. Under the restructuring plan adopted during 1996-97, the Regions were encouraged to host regional meetings where members could get together and exchange ideas. Branson, Missouri, played host to the first Region 6 Meeting, held September 26-28, 1997.

The Second Board Meeting was held at the Holiday Inn in Wichita Falls (Wichita County), September 11-14, 1997, with 79 registrants.

The first specialty certification exam in Texas civil litigation was administered in November 1997.

The Third Board Meeting was held at the Harvey Hotel–Plano (nonhosted) in Plano, February 20–22, 1998.

Eleven members were recognized as being the first to attain specialty certification in Texas civil litigation (TSC): Rita C. Alesi, PLS, CLA; Ruby T. Higgins, PLS, CLAS; Mary Jo Johnson, ALS, PLS; Laura J. Keck; Tracy Kemp, PLS; Katrina A. Magatagan, PLS; Meri Nelson, PLS; Casey L. Robertson; Shari L. Tucker, PLS; Sylvia R. Vela, PLS; and Debbie Wheeler, PLS, CLA.

The 43rd Annual Meeting was held at the Holiday Inn Select in San Antonio (hosted by San Antonio), May 14–17, 1998. At the Annual Meeting, the awards chairman announced the three finalists for Texas ALS Legal Secretary of the Year: Diane Ratliff, PLS, CLA (Fort Worth LSA), Rebecca Lu Tanner, PLS, CPS, CLA (San Antonio LSA), and Elizabeth Wells, PLS (Austin LSA). Rebecca Lu Tanner, PLS, CPS, CLA (San Antonio), was installed as the forty-fourth president of the Texas Association. The investiture was conducted by Installing Officer Judith Smith, PLS, CLA. The following elected and appointed officers were also installed: Kathie Jean Keys, PLS (President-elect), Debbie Wheeler, PLS, CLA, TSC (Vice President), Faynell Poe, PLS (Recording Secretary), Julie A. Abernathy, PLS (Treasurer), Cindy G. Curry, PLS, CLA (Corresponding Secretary), and JoAnn Foote, CLA, PLS, CPS (Parliamentarian). It was announced at the Presidents' Banquet that the finalist selected as Legal Secretary of the Year was Elizabeth G. Wells, PLS (Austin LSA).

The year ended with 24 chapters and a total membership of 757.

1998-1999

For President Rebecca Lu Tanner, professionalism, education, and networking were the ideals which formed the basis of the “pen” with which she would help to write the history of Texas ALS.

The Second Board Meeting was held in Austin (Austin) at the Hilton North Towers in September 1998.

October 1998 brought about the beginning of change for our association when a straw ballot was taken of the members present at the NALS Annual Meeting and Educational Conference in Minneapolis, Minnesota. The majority of the members in attendance voted to place the name change issue before the members once again, and at a special meeting held on March 12, 1999, in Tulsa, Oklahoma, our Association officially became NALS . . . *the association for legal professionals*.

This was the year NALS chose to listen to its members and address their concerns surrounding both the PLS and the ALS programs. The PLS exam was revised and is now a one-day, four-part exam consisting of: Written Communications, Office Procedures and Technology, Ethics and Judgment and Legal Knowledge and Skills. The ALS exam was revised and is now a one-half day, three-part exam consisting of: Written Communications, Office Procedures and Legal Knowledge, and Ethics, Human Relations, and Judgment.

The year also saw the revision to the Texas ALS Long-Range Plan which recommended the elimination of the First Board Meeting traditionally held on Sunday morning following the Annual Meeting and the combination of the Bylaws and Standing Rules Committees. Bylaws and standing rules amendments to accomplish these recommendations were approved by the members.

Finally, in an effort to reach more of its members and potential members, Texas ALS acquired its own web site—www.texasals.org.

The Leadership Committee held a Confederate Caucus for Texas ALS in Midland, November 14, 1998.

The Third Board Meeting was held at the Waco Hilton in Waco (Waco), February 19–21, 1999. There were a total of 108 in attendance, 106 paid registrants (89 members, 10 students, and 6 nonmembers). Special guests attending were Tammy Hailey, CAE, Executive Director of NALS, and Connie Maslowski, PLS, from Helena Montana, NALS President.

The history of Texas ALS was expanded by Recording Secretary Faynell Poe to include annual highlights beginning with the 1995-1996 year.

The 44th Annual Meeting was held at the Holiday Inn-Emerald Beach in Corpus Christi (hosted by Corpus Christi ALP), May 14–16, 1999. It was announced at the Annual Meeting that the three finalists for Legal Secretary of the Year were: Virginia Perales Gil (Cameron County LSA); LaVoice Meier, CLA, PLS (Fort Worth LSA), and Sylvia R. Vela, PLS, TSC (Austin LSA). Kathie Jean Keys, PLS (Corpus Christi), was

installed as the forty-fifth president of the Texas Association. President Kathie's theme was "Accentuate the Positive." The investiture was conducted by Installing Officers Sandra K. Pfluger, PLS, CPS (Corpus Christi), and Sheryl A. Mann, PLS (Corpus Christi), with assistance of Installing Marshals John W. Keys, Robert M. Capeheart, and Peter E. Avots. The following elected and appointed officers served under the leadership of President Keys: Debbie Wheeler, PLS, CLA, TSC (President-elect), Faynell Poe, PLS (Vice President), Julie Abernathy, PLS (Recording Secretary), Cindy Curry, PLS, CLA (Treasurer), Meri Nelson, PLS, TSC (Corresponding Secretary), and Sandra K. Pfluger, PLS, CPS (Parliamentarian). It was announced at the Presidents' Banquet that the finalist selected as Legal Secretary of the Year was Sylvia R. Vela, PLS, TSC (Austin LSA). (Vice President Faynell Poe's membership campaign theme was The Texas Two-Step.) The year ended with 23 chapters and a total membership of 709.

1999–2000

The leadership committee (Dianna Roberts, PLS, chair) held a leadership retreat (based on *The Complete Idiot's Guide to Leadership* by Andrew J. DuBrin) at Pine Needle Lodge, Caddo Lake, July 23–25, 1999.

The 1999 Fall Board Meeting was hosted by FWLSA and held at the Radisson Plaza Hotel Fort Worth in Fort Worth, September 10–12, 1999, with a total attendance of 75. The meeting theme was "Waltz Across Texas."

A Christmas raffle was held at the meeting.

The leadership committee (Dianna Roberts, PLS, chair) held a second leadership retreat in Salado, December 3–5, 1999.

The Texas Institute for Specialty Certification held a Civil Litigation Seminar on Saturday, January 22, 2000, at the Pflugerville Community Library in Pflugerville, Texas.

The 2000 Winter Board Meeting was a nonhosted meeting (Cynthia Huffman, PLS, CLA, TSC, meetings coordinator) and held at the Radisson Resort South Padre Island on South Padre Island, February 10–13, 2000. With the administration of the new one-day PLS exam and half-day ALS exam materials, many new PLSs and ALSs joined the ranks of this fine group of individuals. The Texas Institute for Specialty Certification decided to add an additional specialty area—real estate. A specialty certification mock exam was also begun.

The 45th Annual Meeting was hosted by Lubbock LSA and held at the Holiday Inn-Lubbock Plaza in Lubbock, May 4–7, 2000. The meeting theme was "Celebrations West Texas Style." At the Annual Meeting, the delegates and alternates changed the voting structure of the association at future annual meetings, with the chapter directors being the voting body at the annual meeting. A name change issue came before the association, but, after a membership survey went out, the delegates voted not to make a name change at that time. The following Legal Secretary of the Year finalists were introduced: Virginia Perales Gil (Rio Grande Valley LSP); Alexis Montgomery (Austin LSA); and Judy Stephenson (FWLSA). Debbie Wheeler, PLS, CLA, TSC (NALS of Amarillo), was installed as the forty-sixth President of the Texas Association. The investiture was conducted by Installing Officer Beth Walker, with assistance by Installing Marshals Pete Harland and Ed McConnell. The following elected and appointed officers served under the leadership of President Wheeler: Faynell Poe, PLS (President-elect), Julie A. Abernathy, PLS (Vice President), Cindy Curry, PLS, CLAS (Recording Secretary), Meri Nelson, PLS, TSC (Treasurer), Helene L. 2000–2001

The Winter Board Meeting was hosted by Houston ALS and held at the Four Seasons Hotel in Houston, February 16–18, 2001. The meeting theme was "The Houston Show—Broadway Style." At the Saturday

networking luncheon, a style show was presented with members modeling clothing furnished by Jaeger. The Certification Committee (Kim Culpepper, PLS, TSC, chair) held a Certification Short Course on February 24–25, 2001, in Dallas.

The 46th Annual Meeting was hosted by El Paso County LSA and held at the Hilton Hotel in El Paso, May 17–20, 2001. The meeting theme was “The Edge of Texas.” At the Annual Meeting the following finalists for Legal Secretary of the Year were introduced: Stephanie S. The year ended with 19 chapters and a total membership of 715.

2001–2002

The NALS Region 6 Annual Meeting and Educational Conference was hosted by Texas ALS and held at the Hilton San Antonio Airport in San Antonio, July 20–22, 2001.

September 11, 2000, will be remembered as a day that irreversibly changed the face of our nation and our association. The terrorist attacks on New York and Washington, D.C., were devastating, but they formed the foundation for a new sense of pride in America. United We Stand became a reality, not just an advertising slogan. At the Fall Board Meeting in Dallas, Texas, the membership voted to donate the proceeds of the holiday raffle to the World Trade Center Police and Firemen's Relief Fund.

The Fall Board Meeting was hosted by Dallas ALS and held at the Radisson Hotel Central Dallas in Dallas, September 21–23, 2001. The meeting theme was “Dallas, The Star of Texas.” A standing rule amendment was passed that changed the judging criteria percentages.

The Winter Board Meeting was a nonhosted meeting (Joyce E. Look, PLS, meetings coordinator) and held at the Fredonia Hotel in Nacogdoches, February 22–24, 2002. A PLS/ALS Cram Course was held in conjunction with the meeting.

In March 2002 the Texas Association was a big winner in Tulsa at the NALS Professional Development and Educational Conference. The Texas Association or one of its chapters received the following 2002 Jett Awards: *Cornerstone Award*—(1) Texas ALS (Certification Program Category) for the *Certification Quiz*, (2) Texas ALS (Chapter Development Program Category) for the website *www.texasals.org*, and (3) El Paso County LSA (Chapter Development Program Category) for the *Letter of the Law*; *Keystone Award*—(1) Houston ALS (Large Chapter—CLE Series of Related Topics Category) for the *2001 Beginning Legal Training Course*, and (2) Texas ALS (State Association—Membership Development Category) for the *Kick the Resistance* membership campaign; and the *Founder’s Award* was received by Houston ALS for the *2001 Beginning Legal Training Course*.

The year ended with 19 chapters and a total membership of 704.

2002–2003

The NALS Region 6 Annual Meeting and Educational Conference was hosted by NALS of Oklahoma and held at The Westin-Oklahoma City in Oklahoma City, Oklahoma, July 26–28, 2002. The meeting theme was "From Teepees to Technology." An NEI was held in conjunction with the meeting.

The Fall Board Meeting was hosted by Wichita County LSA and held at the Holiday Inn in Wichita Falls, September 13–15, 2002.

In October 2002 the NALS Annual Meeting was held in Greenville, South Carolina. The finalists for the NALS Award of Excellence were introduced: Nancy Gates, PLS, CLA (Gulf Coast ALSP), Cheryl Summerhill, PLS (Wite County LSP), and Helene Wood, PLS (Houston ALS). (All three finalists were from Region 6.) It was announced at the Silver Time Recognition Luncheon that Texas ALS Member Helene Wood, PLS, had been selected for the 2002 Award of Excellence.

The Winter Board Meeting was hosted by Waco LPA and held at the Hilton Waco in Waco, February 21-23, 2003. The meeting theme was "Rockin' and Rollin' on the Brazos." At the board meeting, Leslie Stokes, PLS, TSC, chair of the Continuing Education Council, distributed the first certificates for the new Texas ALS Excellence in Education Award, a CLE award.

In March 2003 at the NALS Professional Development and Educational Conference, NALS announced that it would begin offering a new certification—the Certified Paralegal Profession (CPP). Inaugural testing was anticipated to take place in March at the 2004 Professional Development and Education Conference in Tulsa, Oklahoma. Inaugural testing was to be given only to qualifying PLSs. CERTIFICATION

We are an education-based professional association. Our members have worked to achieve a standard of professionalism that is recognized throughout the legal community. Just three short years after the formation of Texas ALP, our own Clara Lagow was instrumental in establishing the Certified Professional Legal Secretary examination. Now, 55 years later, Texas can boast of being home to the largest number of certified professionals in the nation with 65 PPs, 1065 PLSs, 511 ALSs, and 116 TSCs.

NALS—PLS . . . *the advanced certification for legal professionals*

NALS instituted its PLS program in 1957, believing that the work of a legal secretary to be professional in nature. However, in order to attain the status of “Professional,” one must be able to perform all of the duties which may be encountered in any law office. Clara Lagow of Fort Worth was appointed chair of a committee to prepare an appropriate examination and to prescribe the method of administering it. Such committee was composed of two educators, two attorneys, and two legal secretaries (Clara Lagow and Elena Rapp), all of Fort Worth, Texas.

The examination was prepared, and in 1958 it was approved by the National Association of Legal Secretaries (International). A Board of Certifying Professional Legal Secretaries was founded with Clara Lagow as Chair.

The first examination was given in April 1960. Since that time, many people from Texas have faced the challenge and passed, entitling them to place the coveted “PLS” after their signatures.

In 1970 Texas ALP published the PLS Cram Test (now known as the Certification Mock Exam), which is periodically reviewed and revised by Texas ALP members who have successfully passed the PLS examination. This test is very comprehensive and of great assistance to members desiring to study for the PLS examination, as well as increase their knowledge of the legal secretarial profession.

NALS—ALS . . . *the basic certification for legal professionals*

In 1992 NALS offered the ALS exam primarily for secretaries with less than one year of legal experience. Many members have taken the ALS exam as a preparatory exam to taking the PLS exam. Texas ALP was a leader in publishing one of the first ALS mock exams in the nation in 1994.

In 1999 NALS once again listened to its members and addressed their concerns surrounding both the PLS and the ALS programs. The PLS exam was revised and is now a one-day, four-part exam consisting of: Written Communications, Office Procedures and Technology, Ethics and Judgment, and Legal Knowledge and Skills. The ALS exam was revised and is now a half-day, three-part exam consisting of: Written Communications, Office Procedures and Legal Knowledge, and Ethics, Human Relations, and Judgment.

NALS—PROFESSIONAL PARALEGAL (PP)

In March 2003, NALS announced a new certification—Certified Paralegal Professional (CPP). Later in 2003, NALS changed the certification to Professional Paralegal (PP) as a result of another association using the CPP designation.

The inaugural testing took place in March 2004. The test was administered at the 2004 Professional Development and Education Conference in Tulsa, Oklahoma. The inaugural testing was given to qualifying PLSs.

PP certification was received by 111 qualified PLSs after successful completion of a three-hour exam on substantive law. Other candidates wishing to take the exam will receive PP certification after successful completion of a four-part, all-day exam, which will include written communications, legal knowledge and skills, ethics and judgment skills, and substantive law.

Qualifications to sit for the exam are five years of legal experience (a candidate may receive a partial waiver of one year if he or she has a post-secondary degree, other certification, or a paralegal certification; a candidate with a paralegal degree may receive a two-year partial waiver).

The PP certification will be valid for five years. Recertification will require 75 hours of CLE. Recertification is mandatory to remain certified as a PP. A PLS who successfully completes the PP exam and wishes to list both certifications should note the certification as PLS, PP.

TEXAS INSTITUTE FOR SPECIALTY CERTIFICATION— SPECIALTY CERTIFICATION

Texas ALP seems to be always on a quest for a new, bigger, and better dream. In November 1997, another Texas ALP dream became reality. After two years and many hours of hard work and determination, the first Specialty Certification exam was given in civil litigation. The exam offers a specialty certification examination for legal support staff based on Texas law in the area of civil litigation. As of the 2004 Annual Meeting, there were 91 members and nonmembers who had attained specialty certification in Texas civil litigation. Additionally, the Institute developed a mock exam for use as a study tool for the civil litigation exam. The Institute is currently working on a specialty certification exam in Texas real estate law.
