

#### PROFESSIONAL DEVELOPMENT By: Barbara S. Akins, PLS

Failure leads to success. Have you heard this and only thought about your failures and not your successes? What does it mean? I believe it means we must challenge ourselves to be successful. My failures, if I believe in myself, could lead to success if I challenge myself. My success might not be like yours, but we can succeed. A perfect example is taking the PLS exam and failing. Does that mean your failures defines you? Not if you want to succeed. And you should. Just remember that "PLS" has no number behind the designation.

Do you know people who always succeed or is it perhaps only that part of that person you know? I have a friend who seemed to succeed in everything she did. She was a legal secretary/legal assistant/office manager who then became a very successful consultant in the legal field. She just seemed to always succeed; however, I also knew her failures. She was not the person who let failure stand in her way or define her. I've tried to emulate that person for more years that I can remember. I never had the successes she did but I had my own successes. And I believe they were right for me. I just failed more along the way.

Have you had some failures along the way? In the last issue we challenged you to add professional and personal development to your life and step out of your comfort zone. Here are some thoughts to consider:

- Replace bad habits. Bad habits seem to sneak upon us. Gossip may make you feel better about yourself but it is a harmful and bad habit. Guard against gossip in the workplace. Only you can make yourself angry. Identify those bad habits first, then replace them.

- Help make changes, and be courageous in your attitude in the workplace. Be willing to be wrong. Strive for peace.
- Don't neglect being with friends. We all need social interaction. That social interaction should be outside the office or on the lunch break. And, always take advantage of the opportunity to attend association meetings. It's great networking and a chance to widen your circle of friends.


From Blake Walterscheid:

#### "Breaking Up Is Hard to Do"

#### **<u>Preface</u>**: Mary and John have been married for many years.

Seven years ago, Mary was considering divorcing her husband, John. At the time, unbeknownst to John, Mary consulted with Johnson, a family law attorney with XYZ Law Firm. Mary wanted to know what her options were and how the property would be split if she were to go through with filing for divorce. At the conclusion of the meeting, Mary was still undecided, so Johnson prepared an engagement agreement and told Mary to sign and return if she decided to retain the XYZ Law Firm.

<u>Conclusion</u>: Mary decided not to go through with filing for divorce, and Johnson did not take any other steps to take her on as a client.

Seven years later, John decides to file for divorce. Unaware that Mary previously consulted with the XYZ Law Firm, John contacts and consults with Clayton, another attorney at the XYZ Law Firm. When Clayton does a conflict check, it turns up the single meeting with Johnson, who is still at the firm. Clayton talks to Johnson, who has no recollection of the meeting or of Mary at all, including anything that might have been discussed. Johnson also says that if any notes were taken, they would have been discarded years ago in accordance with firm policy regarding consultations that don't result in the firm being retained. When learning that John has retained the XYZ Law Firm, Mary makes it clear that she will not waive any conflict of the XYZ Law Firm or its attorneys.

**<u>Issue</u>**: As Attorney Clayton considers whether to take John as a client, which of the following is most accurate under a recent Ethics Opinion from the Professional Ethics Committee for the State Bar of Texas?

- A. Attorney Clayton cannot represent John.
- B. Attorney Clayton can represent John if Attorney Johnson is screened from the representation and does not participate in any way.
- C. Attorney Clayton can represent John if Attorney Johnson is screened *and* the firm has no files or notes related to Mary's consultation five years earlier.
- D. Attorney Clayton can represent John without screening Attorney Johnson because Mary never signed the engagement agreement and therefore never became a client of the firm.

#### Some Life Lessons and Stories to Guide Us Forward in Life

I recently came across an inspiring article by January Nelson (<u>Thought Catalog</u>, January 7, 2019) which contained some life lesson statements with motivational stories. I thought they gave good "food for thought" and gave some perspective on what is important in our current time when events seem so out of control, and in turn lead to a happier life. I wanted to share a few, and maybe more in future editions of The Docket.

#### Laziness won't get you anywhere.

"As a man was passing the elephants, he suddenly stopped, confused by the fact that these huge creatures were being held by only a small rope tied to their front leg. No chains, no cages. It was obvious that the elephants could, at any time, break away from their bonds, but for some reason, they did not.

He saw a trainer nearby and asked why these animals just stood there and made no attempt to get away. 'Well,' the trainer said, 'when they are very young and much smaller we use the same size rope to tie them and, at that age, it's enough to hold them. As they grow up, they are conditioned to believe they cannot break away. They believe the rope can still hold them, so they never try to break free.'

The man was amazed. These animals could at any time break free from their bonds but because they believed they couldn't, they were stuck right where they were."

#### **TEXAS SECRETARY OF STATE CORPORATE DIVISION**

Last year during the midst of the Covid Pandemic, the Texas Secretary of State implemented a new way of filing documents. It is called: **SOSUpload**.

If you want to use the new SOSUpload, you must have a SOSDirect account. To set up an SOSDirect account contact: <u>SOSDirect@sos.tex.gov</u>.

To start, go to the Texas Secretary of State's website: https://www.sos.state.tx.us On the righthand side under SOSDirect is another main heading called "Popular Links," the first listing is "New: SOSUpload" click on this.

Payment for filing a document using SOSUpload is either by credit card or an account that one has with the Texas Secretary of State.

When using the new SOSUpload the document must be in a PDF file format and no other document can be included (credit card information, filing instructions).

Once in you are asked for entity information:

Is this filing for a new entity? YES/NO

#### <u>IF NO</u>:

If it is for an entity already on file it will ask for the **filing number**. Click on: Verify My Filing Number. (TIP: If the document you are filing is for an entity already filed with the Texas SOS the document will have a line item that states the entity's file number.)

Then you will need to verify the entity name, entity type (domestic corporation, domestic limited liability company, etc.), filing type: Amendment, Change of Registered Agent

Then hit NEXT.

OR

#### If YES:

Please enter the entity name, select corporation and filing type and then click NEXT

Enter entity name: (ABC, LLC)

Entity type: corporation, domestic limited liability company, etc.

Filing Type: Certificate of Formation, Amendment, etc.

#### THEN CLICK NEXT

At this point upload the original filing document. Do not include payment information, instruction pages or personal information, <u>if this is included the submission will be rejected</u>.

Once the document is uploaded, then click on "Submit for Review." Be sure to print out the page that shows the document has been submitted.

The new upload system is not designed to accept the following Certificates of Merger or Exchange Resignation of Registered Agent Documents submitted for preclearance

Certificates of Validation

Multiple filing instruments that must have a certain order of filing or are dependent on the review and acceptance of another uploaded document.

When using the SOSUpload the document being filed is considered as being filed EXPEDITED, but you are not charged the \$25 expedited fee as when a document is faxed or delivered to the Texas Secretary of State's Office.

#### **Turnaround Times**:

SOSUpload: 4-5 business days

SOSDirect: 4 business days (this involves filing a document using the TX SOS website)

Expedited documents: 4-5 business days

Non-expedited documents submitted by mail and fax: 22-25 business days

At a recent seminar put on the University of Texas School of Law a speaker from the Texas Secretary of State's Office said that SOSUpload is faster than fax filing and marking the document "Expedited."

One year ago, we met the people that would give our boys an accessible home and change the course of our lives forever.


They are Chip and Joanna Gaines, Tim Tebow and their amazing teams that help carry out their missions of assisting others through their nonprofit foundations.
